Sub: Lawyer Notice


Sir,

On behalf of Kerala State branch of Church of God (Full Gospel) in India (hereinafter, referred to as "Church of God"), the following notice is hereby issued to you for your strict compliance:

It has come to notice that you have been circulating scandalous, false and malicious falsehoods and mistruths against the Kerala State leadership of the Church of God. You have falsely claimed to be an office bearer of BJP/ its affiliated organisations and official nominee of the National Democratic Alliance in Kerala; and under guise of such false claims, you have approached the State leadership of Church of God with several unacceptable demands. Because of your false claims and doubtful integrity, the organisation has always distanced itself from you and your alleged activities. However, since the Organisation has refused to dance to your tunes, you have been deliberately and maliciously publishing, circulating and propagating false, scandalous, defamatory and abusive contents through WhatsApp and other social media platforms against its religious leaders, with the oblique motive to wreck vengeance and malign Church of God in Kerala and its office bearers including overseer

You are hereby put on notice that in the event you fail to comply with this notice, or continue with your illegal and wrongful actions, then appropriate criminal and civil proceedings shall be instituted against you in the competent criminal and civil courts in addition to police and for which you and your assets will be held liable.
